### **COVID-19 Exposure Management Plan**

#### **September 8, 2021 (updated)**

A targeted public health response to contain COVID-19 exposures at a community level can help maximize the impact of the Los Angeles County Department of Public Health (DPH) COVID-19 response.

Our Lady of the Rosary School serving students from Preschool through Grade 8 is a trusted community partner that can help DPH improve the timeliness and impact of the Public Health response through rapid initiation of a COVID-19 Exposure Management Plan (EMP). Immediate implementation of an EMP when a single case of COVID-19 is identified at school can accelerate the ability to contain the spread of infection and prevent outbreaks from occurring.

The steps for managing exposures to 1, 2, 3 or more COVID-19 cases at Our Lady of the Rosary School are described below and summarized in Appendix A.

### **Exposure Management Planning Prior to Identifying 1 COVID-19 Case at Our Lady of the Rosary School**

**REQUIRED:** Vanessa Rivas, Principal, is the designated School COVID-19 Compliance Officer. She is responsible for establishing and enforcing all COVID-19 safety protocols and ensuring that staff and students receive education about COVID-19. She serves as a liaison to DPH for sharing site-level information to facilitate public health action.

**REQUIRED:** There are seating charts in classrooms and participant rosters for students and staff participating in school extracurricular programs to facilitate identification of close contacts of persons with COVID-19 at the school.

**REQUIRED:** The school has a plan for all students, employees, and visitors who have symptoms consistent with COVID-19; students will be isolated and sent home to be picked up by parent. An employee will be sent home and to monitor symptoms and get tested for COVID-19. The school plans to conduct weekly testing for employees and students. Students will require parent's permission. Visitors are prescreened before entering the school. Must visitors make an appointment before being on campus. Students and employees who are quarantined because of exposures the school will follow the [Screening Education Setting Pathway](#) and give them a date to return that follows the 10 to 14 isolation period. OLR will report and work with an active public health investigation and provide parents and employees with information of access to testing or be tested for COVID-19. The COVID-19 testing sites on the [LA County COVID-19 Testing website](#) offer no-cost (free) testing. The [City of Los Angeles](#) also offers free COVID-19 testing.

**RECOMMENDED:** Our Lady of the Rosary School is implementing an asymptomatic screening testing program. Staff and students that are not fully vaccinated are prioritized for regular testing as an important part of identifying infections early to prevent transmission on campus. Fully vaccinated individuals are included in a school's asymptomatic screening testing program, on request and if an active case has been identified and exposure to the active case is suspected.

**RECOMMENDED:** Our Lady of the Rosary School is implementing a DPH-guided symptom screening program prior to school entry or while at school. Our Lady of the Rosary will apply DPH guidance on Decision Pathways for persons who have not been tested yet for COVID-19 but

screen positive for symptoms prior to school entry or while at school. Staff will submit an online report ([Health Screening Form](#)) before arrival at school. Teachers will screen students before entering the classroom. A thermometer is available in each classroom for teachers to conduct temperature checks.

## **Exposure Management for 1 COVID-19 Case at Our Lady of the Rosary School**

**REQUIRED:** After identifying 1 confirmed COVID-19 case (student or employee), the School Compliance Office instructs the case to follow Home Isolation Instructions for COVID-19 ([ph.lacounty.gov/covidisolation](http://ph.lacounty.gov/covidisolation)). NOTE: a confirmed COVID-19 case is an individual who has a positive COVID-19 test.

**REQUIRED:** School Compliance Officer provides a copy of the Public Health Emergency Isolation Order and informs the case that DPH will contact the case directly through the DPH Case and Contact Investigation Program to collect additional information and issue the Health Officer Order for Case Isolation.

**REQUIRED:** School Compliance Officer works to identify all individuals in the School who have had an exposure to the confirmed positive case during their infectious period (Close Contacts).

- A case is considered to be infectious from 2 days before their symptoms first appeared until the time they are no longer required to be isolated (i.e., no fever for at least 24 hours, without the use of medicine that reduce fevers AND other symptoms have improved AND at least 10 days have passed since symptoms first appeared). A person with a positive COVID-19 test but no symptoms is considered infectious from 2 days before their test was taken until 10 days after their test.
- Close Contact: A person is considered to have been exposed to a case during the infectious period if at least one of the following criteria is met:
  - Being within 6 feet of the infected person for 15 minutes or more over a 24-hour period.
  - Having had unprotected contact with the infected person's body fluids and/or secretions of a person with confirmed COVID-19 (e.g., being coughed or sneezed on, sharing utensils or saliva, or providing care without using protective equipment).
- Exposures will be reviewed by Public Health to assess which persons need to quarantine including the possibility of quarantining all individuals in the same cohort or classroom as an infected person if exposures cannot be ruled out for the entire group. NOTE: Exposures associated with youth sports programs will be reviewed by Public Health to confirm which persons need to quarantine, including the possibility of quarantining all individuals on the same team with an infected person (or individuals on an opposing team who were playing against a team with an infected person), if exposures cannot be ruled out. Please refer to the [Exposure Management Plan for Youth Recreational Sports Programs](#) for specific guidance.

**REQUIRED:** School Compliance Officer must notify DPH of (1) employees, children, and visitors with confirmed COVID-19 who were on campus at any point within the 14 days prior to the illness onset date (school-associated case) and (2) persons on campus who were exposed to the infected

person during the infectious period. The illness onset date is the first date of COVID-19 symptoms or the COVID-19 test date, whichever is earlier.

- **REQUIRED:** All school-associated COVID-19 cases and persons identified to have had an exposure to cases on campus should be reported online through the secure web application: <http://www.redcap.link/lacdph.educationsector.covidreport> If online reporting is not possible, reporting can be done manually by downloading and completing the COVID-19 Case and [Contact Line List for the Education Sector](#) and sending it to ACDC-Education@ ph.lacounty.gov. All case notifications should be submitted within 1 business day of being notified of the case.
- **Recommended:** Schools that are reporting a school-associated COVID-19 case to DPH for the first time or need assistance on COVID-19 exposure management can call the TK-12 School COVID-19 Case Reporting Call Center, Monday through Friday from 8:00AM to 5:00PM. School administrators that do not have the Call Center number should contact [ACDC-Education@ph.lacounty.gov](mailto:ACDC-Education@ph.lacounty.gov) for the number.

**REQUIRED:** All persons identified to have had an exposure to a COVID-19 positive case at school are notified by the School Compliance Officer of the exposure through a letter or other communication strategies and a copy of the [Public Health Emergency Quarantine Order](#). A School Exposure Notification letter template is available at: [COVID-19 Template Notification Letters for Education Settings](#) (Template #1). The notification of exposure should include the following messages:

- DPH is coordinating with the school to contact persons who are identified as having had close contact with the school-associated case to gather additional information and provide guidance on testing and quarantine.
- Employees with a campus exposure should follow guidance outlined in Cal/OSHA COVID-19 Prevention [Emergency Temporary Standards](#) (ETS). A summary of requirements is provided in the Public Health guidance document on [Responding to COVID-19 in the Workplace](#).
- Persons with an exposure to the case should test for COVID-19 and inform the school of test results. This will determine the extent of disease spread at the school and serve as a basis for further control measures. Testing resources include: Employee Health Services or Occupational Health Services, Student Health Center, Personal Healthcare Providers, Community Testing Sites: [covid19.lacounty.gov/testing](https://covid19.lacounty.gov/testing). Individuals who need assistance finding a medical provider can call the LA County Information line 2-1-1, which is available 24/7.
- Exposed persons who are not fully vaccinated must self-quarantine (stay in their home or another residence, separate from others) and monitor for symptoms for 10 days from their last contact with the case while infectious (as defined above). If they remain asymptomatic, quarantine can end after Day 10 from the last date of exposure without testing but they must continue to monitor their health and adhere to COVID-19 prevention precautions through Day 14. Quarantine may end after Day 7 for exposed students who remain asymptomatic, if a diagnostic specimen is collected after Day 5 from the date of last exposure and tests negative, but they must continue to monitor their health and adhere to COVID-19 prevention precautions through Day 14. **Note the test must be an FDA-authorized viral COVID-19 test, including a Nucleic Acid Amplification Test (NAAT, such**

as PCR) or an Antigen test, that is collected and done in a healthcare setting or certified testing site.

- NOTE: Asymptomatic persons who are [fully vaccinated](#) AND who are a close contact to a confirmed case are recommended to test for COVID-19 as a result of their exposure but are not required to quarantine. However, they should monitor for symptoms of COVID-19 for 14 days following an exposure. Persons who have recovered from laboratory-confirmed COVID-19 within the last 90 days AND who are a close contact to a confirmed case are not required to quarantine or test for COVID-19.

**Recommended:** School Compliance Officer will determine whether additional notification is needed to inform the wider school community about the school exposure and precautions being taken to prevent spread of COVID-19. ### **Exposure Management for 2 COVID-19 Cases at Our Lady of the Rosary School within a 14-day Period**

**REQUIRED:** After identifying 2 confirmed cases (students and/or employees) within a 14-day period, the school follows the steps for 1 confirmed case.

**REQUIRED:** School Compliance Officer consults with Public Health to determine whether the 2 cases are epidemiologically linked, meaning that the two affected individuals were both present at some point in the same setting during the same time period while either or both were infectious.\* Schools should contact DPH for assistance in determining whether cases are epidemiologically linked by emailing [ACDC-Education@ph.lacounty.gov](mailto:ACDC-Education@ph.lacounty.gov) or by calling the TK-12 School COVID-19 Case Reporting Call Center.

\*A case is considered to be infectious from 2 days before symptoms first appeared until they are no longer required to be isolated (i.e., no fever for at least 24 hours without the use of medicine that reduces fever AND other symptoms have improved AND at least 10 days have passed since symptoms first appeared). A person with a positive COVID-19 test but no symptoms is considered to be infectious from 2 days before their test was taken until 10 days after their test.

Determination of epidemiological links between cases may require further investigation to assess exposure history and identify all possible locations and persons that may have been exposed to the case while infectious at the site. NOTE: **Epidemiologically linked cases include persons with identifiable connections to each other such as sharing a physical space (e.g. in a classroom, school event, sports team, other extracurricular activities, school transportation, office site), indicating a higher likelihood of linked spread of disease in that setting rather than sporadic transmission from the broader community. If epidemiological links exist, DPH will advise the school on important steps to take and communications to students and employees on precautions to take to prevent further spread at the school, including implementation of site-specific interventions for infection control.**

### **Exposure Management for ≥ 3 or more COVID-19 Cases at Our Lady of the Rosary School within a 14-day Period**

**REQUIRED:** If the school identifies a cluster of 3 or more confirmed cases (students and/or employees) within a 14-day period, the school shall proceed with the following steps:

- Report the cluster immediately to DPH by calling the TK-12 School COVID-19 Case Reporting Call Center or by submitting a report online at: <http://www.redcap.link/lacdph.educationsector.covidreport>. If online reporting is not possible, reporting can be done manually by downloading and completing the [COVID-19 Case and Contact Line List for the Education Sector](#) and sending it to [ACDC-Education@ph.lacounty.gov](mailto:ACDC-Education@ph.lacounty.gov).
- DPH will review the submitted information to determine whether the outbreak criteria described below have been met and will notify the school within 1 business day on next steps.
- Outbreak Criteria: At least 3 confirmed cases with symptomatic and asymptomatic COVID-19 within a 14-day period in a group with members who are epidemiologically linked, do not share a household, and are not a close contact of each other outside of the campus.
- School groups include persons that share a common membership at school (e.g., classroom, school event, school extracurricular activity, academic class, sport teams, clubs, transportation). Epidemiological links require the infected persons to have been present at some point in the same setting during the same period while infectious.
- NOTE: For overnight camps, a “household cohort” means cabinmates (campers and staff) who are staying together in a cabin, bunkhouse, or similar space. Additional guidance regarding overnight camps is located in the Reopening Protocol for [Overnight Organized/Children’s Camps: Appendix K-1](#).
  - If outbreak criteria are not met, DPH will advise the school to continue with routine exposure management.
  - If outbreak criteria are met, DPH will notify the school that an outbreak investigation has been activated and a public health investigator will communicate directly with the school to coordinate the outbreak response.

**Appendix A: Steps for Managing Exposures to COVID-19 Cases at School**

<b>1 Case</b>	<ol style="list-style-type: none"><li>1) <i>Required:</i> School instructs the case to follow COVID-19 Home Isolation Instructions.</li><li>2) <i>Required:</i> School informs the case that DPH will contact the case directly to collect additional information and issue Health Officer Order for Isolation.</li><li>3) <i>Required:</i> School works with DPH to identify school contacts. Schools can call the TK-12 School COVID-19 Case Reporting Call Center for assistance with identification of close contacts and exposure management.</li><li>4) <i>Required:</i> School notifies school contacts of exposure. School contacts are instructed to quarantine at home, test for COVID-19 due to their exposure, and issued the <a href="#">Public Health Emergency Quarantine Order</a>.</li><li>5) <i>Required:</i> School submits a report to DPH within 1 business day with information on the confirmed case and persons who were exposed to the case at the site. Schools that are reporting a case for the first time or require assistance in exposure management should call the TK-12 School COVID-19 Case Reporting Call Center or email <a href="mailto:ACDC-Education@ph.lacounty.gov">ACDC-Education@ph.lacounty.gov</a> for assistance.</li><li>6) <i>Recommended:</i> School sends general notification to inform the school community of the school exposure and precautions taken to prevent spread.</li></ol>
<b>2 Cases</b>	<ol style="list-style-type: none"><li>1) <i>Required:</i> Follow required steps for 1 confirmed case.</li><li>2) <i>Required:</i> If the 2 cases occurred within 14 days of each other, school consults with DPH to determine whether the cases have epidemiological (epi) links. If epi links exist, school implements additional infection control measures. Schools can call the TK-12 School COVID-19 Case Reporting Call Center or email <a href="mailto:ACDC-Education@ph.lacounty.gov">ACDC-Education@ph.lacounty.gov</a> for assistance in determining whether cases have epidemiological links.</li></ol>
<b>3+ Cases</b>	<ol style="list-style-type: none"><li>1) <i>Required:</i> If a cluster of 3 or more cases occurred within 14 days of each other, the school immediately notifies DPH by calling the TK-12 School COVID-19 Case Reporting Call Center or reporting online at: <a href="http://www.redcap.link/lacdph.educationsector.covidreport">http://www.redcap.link/lacdph.educationsector.covidreport</a>.</li><li>2) <i>Required:</i> DPH determines if the outbreak criteria have been met. If outbreak criteria are met, a DPH outbreak investigation is activated, and a public health investigator will contact the school to coordinate the outbreak investigation.</li></ol>
